### 经开区经济贡献 Economic Contribution of NETDZs

## 据商务部外资司2023年发布数据,2022年国家级经开区以全国0.3%的土地面积创造了占全国12%的地区生产总值

According to the data released by the Department of Foreign Investment Administration of MOFCOM in 2023, By the year of 2022, 230 NETDZs contributed 12% of China's GDP, with only 0.3% land area of the whole country.

- 税收收入 /Tax Revenue: 2.3 trillion RMB, 占全国总税收收入的 13.8%
- 财政收入 / Financial Revenue:2.5 trillion RMB,占全国总财政收入的**12.3%**
- 地区生产总值 / Regional GDP: 15 trillion RMB,占全国总地区生产总值的**12.4%**
- 进出口总额 / Total Volume of Import & Export: 10 triilion RMB, 占全国进出口总额的22.8%
- 利用外资金额 / Utilization of Foreign Capital: \$ 42.3 billion, 占全国总利用外资金额的 22%
- 科技创新企业 / Hi-Tech and Innovation Enterprises: **50,300** (2021)



#### 绿色鼓励政策 Green Policies and Subsidies Released by Development Zones

据不完全调研统计,2019-2021年,11家国家级经开区已出台13部绿色激励政策,最高补贴金额超亿元。

From 2019 to 2021, 11 NETDZs have issued 13 policies and subsidies to encourage green and low-carbon transition, with a highest subsidy of one billion yuan.




#### 绿色智慧管理 Intelligent Digitalization Management in Development Zones

据不完全调研统计, 25 家园区开展了智慧环保(环境应急监测)、循环经济、


能源管理等领域的数字化、智慧化绿色管理。

## 国际合作产业园 International Cooperation Parks



• 图为全国各省国际合作园区分布示意图 Distribution of International Cooperation Parks

- 全国共建设6个基于双边商贸协定推动的国际合作生态园;
  - 6 ecological international cooperation parks established under national-level bilateral agreement;
- 有11个省份推动建立了各级各类国际 合作园区87个;
  - Currently, there're **87** international cooperation parks in **11** provinces;
- 其中,中欧合作产业园区42家,占中国全部国际合作产业园数量的48%。
  - Among them, **42** are Sino-European cooperation parks, taking up **48%**.



## 天津泰达的低碳之路 TEDA: Path to Carbon Neutrality



- On June 28th, during Tianjin Summer Davos Forum, Tianjin Economic-Technological Development Area (TEDA) officially joined the World Economic Forum's Industry Cluster Transition to Net Zero Initiative, becoming the first NETDZ and industrial park in China to join the initiative.
- TEDA is one of China's earliest three eco-friendly industrial parks as recognized by MEP, MOST and MOFCOM.
- It is also one of China's earliest pilot zones for circular economy, consistently leading the nation's industrial parks in green and lowcarbon development.
- Up to now, TEDA has a cumulative total of 22 national-level green factories, 12 green supply chain management enterprises, and 2 green design product companies. There are 55 green factories in Tianjin, which have initially achieved the demonstration effect of regional green manufacturing aggregation, continuously promoting the transformation of industries towards low-carbon development.
